Offense	Fine Amount Plus Costs
Driving While License Suspended/Revoked/Cancelled	Up to \$500.00 fine plus \$216.00 court costs
Reckless Driving	Up to \$500.00 fine plus \$166.00 Court Costs
Passing a School or Church Bus	Up to \$500.00 fine plus \$166.00 Court Costs
