Council member Strickland moved to approve the request of Public Works Director Hilry King, that the Mayor be given the approval to sign an agreement between Gresham, Smith and Partners and the City of Columbiana, Alabama, for Construction Engineering & Inspection Services: Project No. STPTE-TE07(923) & HPP-A129(900)---Main Street Sidewalk. Council member Seale seconded and the motion passed by a majority vote of five (5) to one (1), with Council member Handley casting the nay vote, and the Mayor declared the motion passed.
