# RESOLUTION 11-20-07 RESOLUTION AUTHORIZING A ONE-TIME LUMP SUM PAYMENT TO EMPLOYEES

WHEREAS, the Columbiana City Council would like to provide a one-time pay increase to its employees; and

WHEREAS, the Columbiana City Council has adequate funds in the payroll account to cover this expenditure that is included in the FY 2021 Budget; and

WHEREAS, it is the responsibility of the City Council to approve a budget that is consistent with the revenue and expenditures reflecting their priorities for the City of Columbiana and wishes to provide the increase to employees.

**NOW THEREFORE BE IT RESOLVED** by the City Council of the City of Columbiana that the City Council hereby authorizes the payment of a one-time lump sum payment for all active full-time and all active part-time employees, in the amount of \$225.00 (net pay) for full-time employees and \$125.00 (net pay) for part-time employees, in active status as of November 13, 2020, and having worked at least their budgeted number of hours since October 1, at an approximate cost to the City of \$13,500.00.

**THEREUPON** Council Member Phillips moved and Council Member Ruston seconded the motion that said resolution be given vote, and said resolution passed by roll call vote of all members of the Council and the Mayor declared the same passed.

### **Discussion – Other City Business**

The following announcements were made:

- City Hall will be closed Thursday, November 26 and Friday, November 27 for Thanksgiving. There will be no garbage pick-up on those days.
- Business License renewal notices will be mailed no later than December 15.
- The next court will be held on November 24 at 2:00 pm. Court will only hold one court in December and that is on the 8<sup>th</sup> at 2:00 pm.
- The Police Department is sponsoring their first annual Candy Cane Buddies program to help parents that need assistance with Christmas. Mundy Motors is sponsoring and the peer helpers at Shelby County High School are volunteering. Candy canes can be picked up after December 1 and parents will pick presents up on December 20.
- The Library was awarded \$9000 of the \$10,000 LSTA Collection Development Grant applied for from Alabama Public Library Services. This will be used for their non-fiction collection.
- The Senior Center is delivering 50 meals each week day to the homebound in Columbiana. They have stopped Coffee on the Patio and Picnics on Friday for now because Shelby County is red on the COVID map.
- The city web-site is being revamped.
- The fire department is currently taking applications for volunteer firefighter positions.

## Mayor's Report

- The mayor is hoping to have his 100 Day Plan completed by the end of the month and published on the city's web-site.
- The mayor and council are working on boards and commissions vacancies and are hoping to have these by the next council meeting.
- The city needs to update and create new policies and procedures. The city now has a credit card policy and needs to create a travel policy. These will be review, created and updated with the policy committee.
- The city and Old Mill Square have separate web-sites. We are hoping to consolidate these into one web-site and are making enhancements to our web-site.
- The mayor met with 58 Inc. regarding vision, strategic planning and economic development. He is hoping to have a conference next quarter at the Grande Hall focusing on Shelby County and Columbiana. 58 Inc. is working on a conference in January and it will be held at the Grande Hall.
- The mayor gave an update on the FY 2020 budget along with October 2020 and FY 2021.
